# COMGEST TO SEGREGATE CEO AND CIO ROLES

Comgest, the independent global asset management firm, announces the intention to segregate the roles of Chief Executive Officer (CEO) and Chief Investment Officer (CIO), effective from 31 December 2022<sup>1</sup>. Arnaud Cosserat, who currently holds both positions, will remain CEO and Franz Weis will be appointed CIO. A gradual transition of the CIO roles and responsibilities will take place throughout 2023.

With Comgest's bottom-up stock selection process and broad partnership structure, the CIO role focuses on maintaining the firm's quality growth investment culture and ensuring the required tools, processes, and resources are in place. Each investment team is responsible for directing their research and portfolio construction, working collaboratively with other teams to cross-fertilise knowledge and stimulate idea generation.

Arnaud Cosserat was appointed CEO/CIO of Comgest in January 2016, having joined in 1996 as a member of the European investment team. Following Comgest's growth over the past decade, with today over 200 employees located globally across nine offices, it was agreed that it would be best practice to segregate the two roles and the plan for a gradual transition of CIO responsibilities was put in place. Arnaud Cosserat will continue in his roles as CEO and a co-lead Portfolio Manager on a number of European equity portfolios. He will remain a member of the Investment Committee.

Franz Weis has been a Portfolio Manager of European equities at Comgest since 2005, becoming head of the team in 2012. Following the CIO appointment, Franz will continue in these roles. He has been a member of the Executive Committee since 2014, and as CIO, Franz will become Chair of the Investment Committee.

Arnaud Cosserat commented: "The integrity and consistency, of Comgest's quality growth investment approach, are of fundamental importance to the firm and our clients. I have worked alongside Franz at Comgest for over 17 years, and I am certain he is best placed to continue to nurture our unique investment culture, established by our founders more than 30 years ago."

Franz Weis commented: "I look forward to succeeding Arnaud as CIO of Comgest and ensuring the ongoing delivery of our singular quality growth investment approach. We will continue to enjoy our everyday interactions within the European investment team, analysing stocks together as we have done since I joined in 2005.
